


Consideration for a Shared Parking Lot at Sunset Woods Park

Community Meeting 8/21/2023

On August 21st, the Park District of Highland Park hosted a community meeting to share more information about the proposal brought to the Park District by HillCo apartments for consideration to construct a shared parking lot on the Northeast corner of Sunset Woods Park. Feedback collected will be shared with the Park Board of Commissioners. The Park Board will be evaluating an agreement with HillCo on September 13th and 27th. The proposed parking lot will be evaluated by the City of Highland Park Plan and Design Commission on September 5th.



In June, Hillco approached the Park District with a proposal for a shared parking lot, to be located across the boundary line of Sunset Woods Park and Hillco's apartment building property to the east. Hillco needs additional parking spaces because it will no longer be able to use the parking at GreenBay school.

The image on the right identifies the proposed parking lot location in context of the larger park. Sunset Woods Park is outlined in purple, and the general location of the proposed parking lot is outlined in a white dotted line. Hillco's property is represented by the orange box.

The image on the left is a zoomed in view of the Northeast section of the park and highlights the parcel boundaries.

1. Project Background/Purpose (b) Hillco Request for shared property use



The shared parking lot is proposed to sit partially on Hillco property and partially on Sunset Woods property. Shaded in yellow is the proposed parking lot, which will contain 17 spaces. The red outline is Hillco's property line. The entrance to the parking lot is intended to line up with Midlothian to the North.

1. Project Background/Purpose (c) Park District's Consideration



The Park District is considering existing conditions and evaluating whether the proposal for a shared parking aligns with the District's mission, values, strategic initiatives and master plan,

PDHP Mission: To enrich community life through healthy leisure pursuits and an appreciation of the natural world.

PDHP Values: The Park District strives to create welcoming, caring and extraordinary experience and places.

Strategic Initiative: In effort to grow the Park District's strategic initiatives, The District in collaboration with the Parks Foundation seeks partnership opportunities that benefit the District and the community.

The Sunset Woods Master Plan identifies the Northeast section of the park as an opportunity to develop a gathering area and/or garden space.

1. Project Background/Purpose (c) Park District's Consideration (Sunset Woods Master Plan) Sunset Road Park District's Consideration (Sunset Road Sunset Road

The Sunset Woods Master Plan includes a recommendation to activate the portion of the park (Northeast corner).

Circled in red, you'll see "K" which details the concept for the Northeast section of the park. The concept to activate this portion of the park is an unfunded project and has not yet been designed. A parking lot would provide ADA spaces to provide accessibility to this part of the park.


1. Project Background/Purpose (d) Hillco Letter of Intent

- Construction Cost paid by Hillco
- Final engineering approved by Park District
- \$100,000 donation by Hillco
- Easement Agreement (no property exchange)
- Hillco conduct maintenance; plowing, sealing, striping, patching.

In July, Hillco brought a letter of intent to the Park District Board for consideration at the July 26, 2023 Park Board Meeting.

The letter states:

- Construction of the project will be paid for by Hillco
- Final engineering/design of the parking lot would need to be approved by the Park District
- Hillco would donate \$100,000 to the Parks Foundation of Highland
 Park, to go towards the development of a garden, in line with the Sunset Woods
 Master Plan.
- Hillco and the Park District would enter into an easement agreement, so no property would be sold or exchanged, Hillco would have an easement and the Park District property would remain Park District property.
- Hillco would be required to conduct regular maintenance of the parking lot, including plowing, sealing, striping and patching. If the parking lot needs to be redone, Hillco and the Park District would split the costs 50/50.



Hillco's proposed project plan. Please note, that the path shown West of the parking lot is not part of the project and is intended for scale purposes to represent possible activation of the area. The construction of the parking lot is the development being considered at this time. The garden area and pathwork on the West side of the parking lot are not part of this project and the full scope of work to create a garden and new paths has not been developed or funded.

2. Proposed Project Plan





The images above depict where the parking lot would fall on Park District property. The proposed parking lot would require the removal of the backstop and the existing path along the Easternmost portion of the park.

(The photos are taken facing Northeast and looking towards Park Avenue W.)

The proposed plan will be considered by the City of Highland Park Plan and Design Commission on September 5

The Easement Agreement between the Park District of Highland Park and HillCo will be reviewed at the September 13 and considered for approval at the September 23 meeting. If approved, the earliest construction would begin on the paring lot would be October. Concurrently, the Park District would begin site planning in collaboration with the community in the fall to activate the Northeast corner.

SUNSET - FAQs

Q: How many parking spaces are included in the proposed plan?

A: 17 spaces in total, with 2 ADA spaces constructed on the Park District's side.

Q: Why are ADA parking spaces being considered?

A: If the Park District moves forward with activating the Northeast corner of the park, thus creating a destination, ADA Parking spaces would be required for access. The route from the existing ADA parking on Sunset Road to the Northeast corner and proposed park development concept is not ADA compliant.

Q: How big is the proposed parking lot?

A: The proposed parking lot would be about 7,000 square feet, and approximately 4,000 square feet would be located on Park District property.

Q: If parking lot is approved, will there still be pathway access into the park?

A: Yes, the existing path on the Western and Southern edges of the open lawn space will remain.

Q: Will the McCaffrey Trail be impacted?

A: The parking lot will not impact the McCaffrey Trail.

Q: How many parking spaces are needed for the Hillco tenants, what is the minimum requirement?

A: 8 spaces.

Q: Does Hillco have a plan B?

A: Yes, Hillco has an approved plan for a parking lot that would be in front of their building along Park Ave W. and would contain 12 parking spaces. See the approved plan here (page 11). Hillco has indicated they will build only one parking lot.

Q: How much do tenants of the apartment complex pay for parking?

A: Nothing.

Q: Why do the apartments need parking now?

A: The apartment complex is currently using the School District 112 lot for parking and that lot is no longer available for use due to the temporary location of Ravinia School.

Q: When will there be more clarity on the easement conditions?

A: If the project is permitted at the September Planning and Design Commission meeting, the proposed easement agreement would be reviewed and considered for approval by the Park Board on September 13 and September 23, 2023. Park Board Meetings are public and the agendas are posted on the Park District's website.

Q: Does the proposed parking lot include lighting?

A: No, the proposed parking lot does not include lighting.

Q: Is the proposed garden approved?

A: The activation of this corner of the park, as proposed by the Sunset Woods Master Plan, has not been approved and the concept has not been further developed. The addition of a garden and new paths is currently an unfunded project. The donation from Hillco would provide the Parks Foundation of Highland Park with \$100,000 to go towards development of concept for a garden and park gathering area.


